** Please specify the time you require the bride and wedding party to be ready, please consider first looks, photos before the ceremony starts, etc.*

FEES

Fees will be charged based on a flat base rate of \$1,150 + GST. This price includes the bridal trial, styling for the bride on the wedding day and up to four (4) additional members of the wedding party. Any additional styling (up to 10 party members) will be charged as follows:

Per Person: \$200 + GST

Use of clip-in extensions and hair pieces: \$30 + GST

Additional Time: \$200/hr + GST

**Additional time includes but is not limited to any time booked following the initial styling of the bride and bridal party. This could be pictures on location, touch-ups before the first look, and touch-ups after the ceremony.*

***Please Note:** Groups exceeding 10 individuals will receive a customized quote, as additional stylists/assistants may be necessary.*

TRAVEL FEES

A travel fee is included in the base amount and covers locations within Kelowna. An additional fee will apply to locations outside the city and will be quoted accordingly.

Kelowna includes; Lake Country (ending in Oyama), West Kelowna, and Westside Road (ending at Fintry)

POLICIES AND TERMS

DEPOSIT & PAYMENT

A 50% non-refundable deposit and the signed contract are required to reserve and hold the date. The date is held when the deposit and signed contract are confirmed.

The deposit can be sent by Interac e-transfer to info@pommesalon.ca

***Please Note:** The outstanding balance must be settled in full on the wedding day. All payments made on the wedding day will be subject to applicable taxes.*

TRIAL

A trial is recommended a minimum of 4 weeks before the wedding date. Please have **all** and any extensions, hair pieces, or photos with you during your trial. The trial styling location (within Kelowna) will be coordinated directly with the stylist.

CANCELLATION FEE

Any cancellation within 4 weeks will result in a charge of 50% of the outstanding balance.

Pomme Salon Inc. reserves the right to decline service if the terms and policies are not adhered to by the bridal party.

Pomme Salon Inc. can cancel without notice due to an act of god or a family matter within 48 hours of the scheduled appointment.

DELAYS

Please arrive on time as per the provided schedule. The stylist cannot be held accountable for any compromise in quality resulting from delays.

The stylists present have the right to refuse service on behalf of Pomme Salon Inc. if the bridal party is thirty minutes or more late without previous notice.

PREPARATION

All clients on the wedding day MUST arrive with washed and dry hair.

Please note that this must be done the night before the wedding. No hot tools are to be used on the hair (flat iron, curling iron, etc.) as this can compromise the longevity of your style.

All clients are not permitted to have any excess hairspray, dry shampoo, gels or waves in the hair before service.

All clients MUST have clean hair. The stylist has the right to refuse service if the hair is dirty or if there is a buildup of oils or dirt on the scalp, this will compromise the style.

Clients, especially the bride, are encouraged to follow the homecare recommended by the lead stylist at least four weeks leading up to the wedding day to ensure the longevity of the style.

The stylist has the right to refuse service if the preparation requirements are not met.

The stylist is not responsible for the hair falling or losing shape if the above points are not followed.

Please wear a robe or zip-up garment that will not compromise the styling while

changing into your formal attire. The stylist is NOT responsible for any hair falling out or shape loss if the client has to pull a garment over the head.
